ORDER:

In the order first read above the GOI, MHA have allowed inter-state movement of pilgrims, tourists, students and other persons who are stranded at different places due to restrictive / prohibitory measures. The order mandates the State Government to designate a nodal authorities to have co-ordination with respective State/UT Government to ensure the movement of stranded persons to and from States / UTs, as per the standard protocols developed for the purpose.
