## Order

### Night Curfew Imposition

Dated 1<sup>st</sup> July '20

1. Whereas, the MHA Govt. of India vide its order No. 40-3/2020-DM-1(A) dated 29.06.2020 has decided to re-open more activities in lockdown in a calibrated manner. **I, Amit Khatri, IAS, District Magistrate Gurugram** invoking the powers conferred under Section 144 CRPC, I do hereby prohibit the following in the interest of maintenance of public health, hygiene and safety in view of the COVID-19 pandemic.
2. Movement of any individual other than for essential purposes including operation of industrial units in multiple shifts, movement of persons and goods on National and State Highways, loading and unloading of cargo and travel of persons to their destinations after disembarking from buses, trains and airplanes shall henceforth remain restricted between 10:00 PM to 05:00 AM within the district until 31.07.2020.
3. The compliance of this order shall be strictly enforced and ensured by all Executive Magistrates/ Police Officials on duty and any violation of the same shall be strictly dealt with as per sections of 188, 269 and 270 of the Indian Penal Code, 1860.
4. The order shall be promulgated by uploading it on the District website, circulating it through WhatsApp groups, and on other mediums of social/ digital media. Whenever the same is not possible through these methods, means of mass communication like radio, television may also be used and publicity vans be also deployed to disseminate the same.
