Chairperson's Message

Our objective as AmCham is to complement the efforts of U.S. companies in India and advocate for an equitable, transparent and predictable operating environment. Our work to date aims at leveraging our collective expertise across our member groups while promoting the ease of doing business in India.

This season we have been very busy with various engagements across September and October. This newsletter will give you an update of some of the key initiatives and activities of AmCham.

Accompanied by some members of our National Executive Board, I led AmCham's Annual Door Knock Delegation to Washington DC. We met several key people in the U.S. administration who are engaged with India on economic matters and conveyed a positive message of a changing and improving business climate in the country. The ease of doing business in India and efforts of the present government in converting India into an attractive business destination were discussed at length. We conveyed our collective concerns on infrastructure bottlenecks and lack of logistics support for companies but these were also seen as emerging business opportunities for companies engaged in the infrastructure space. Concerns on the aggressive tax environment and multiplicity of regulatory bodies also came up. The fact that the present government in India is actively engaged in stakeholder consultation and keen on incorporating the advice and suggestions of stakeholders across sectors was well received. The government is moving fast to make India a preferred investment destination. The genuine efforts of the central government is expected to take time to yield results. AmCham also projected success stories of some of the prominent member companies in a prepared note showcasing a positive and encouraging business climate.

With the Smart City policy of the central government in place the business activity is fast shifting to the state governments. We are in the process of reaching out to some of the concerned departments and agencies in the states related to urban development, infrastructure and energy. All members engaged in Smart City business are welcome to participate actively in our outreach efforts in Chhattisgarh, West Bengal, Andhra Pradesh, Telangana, Maharashtra and other states. In our interactions with the state government agencies, AmCham companies have offered solutions in infrastructure, ICT, healthcare, energy, waste management, environment and related Smart City sectors.

The revised draft of the National Civil Aviation Policy (NCAP 2015) has been released and I am glad to note that most of AmCham's suggestions have been incorporated

Executive Director AmCham in the policy. It is now a question of implementation and execution. The union ministry suggested that we increase our outreach to some of the state governments where regional connectivity has distinct potential and request implementation of the central policy on aviation. Regional connectivity, establishment of MROs and capacity building in civil aviation offer a large potential for some of our members. In the defence sector, our members have been meeting the concerned officials periodically to get our views across. The concerned committee of the Defence Ministry has given us sufficient hearing and conveyed some of our suggestions for inclusion in government policy especially on offsets.

We have increased our engagement in sharing experiences and best practices in HR, CSR and other segments. Consequently, the HR group organized competitions on SMAC proposals and came up with excellent presentations outlining unique suggestions on engaging the millennials in each organization. Site visits for members to examine select CSR projects undertaken by member companies in and around Delhi/NCR has been a new initiative where participation by members have been very encouraging.

The Hyderabad chapter organized a national healthcare conference for the third consecutive year. This was great success and we must regularly organise national events at the regional levels every year. The West Bengal government reached out to members not just in Kolkata but across Northern and Southern regions by hosting exclusive events for our members in Bangalore on IT and New Delhi on smart cities. This is a new trend in state outreach which some of the state governments would benefit by emulating.

DIPP has asked AmCham to list out the challenges and issues of individual companies which need to be addressed and resolved. AmCham has been submitting a list of issues and possible solutions on a regular basis and some of them were resolved satisfactorily. Our tax and tariff committee has taken extensive inputs from members and presented their tax proposals to the finance ministry. The medical devices sector continues to face challenges by the regulators and has been meeting regularly to prepare and present their views collectively.

Our activity calendar is sent to each member individually every week. This lists out the upcoming events, past events and programs at a national level. Do participate and encourage the relevant person from your company to be present at such events.

I request you to send us a note on concerns, challenges and problems that are faced by your company in doing business in India. We will highlight these issues with the DIPP, MEA and concerned ministry at the state and central government levels. I also request members to share information and make AmCham a truly representative platform for real time discussions on emerging challenges to the business environment and potential solutions.

Interactive Session with the West Bengal Government

On 7th September 2015, AmCham members held an interactive session with the visiting Government delegation from West Bengal led by Dr. Amit Mitra, Minister-in-Charge of Finance, Excise, Commerce & Industries, Public Enterprise, Industrial Reconstruction, Commerce and Industry, Government of West Bengal, along with the Principal Secretary Urban Development Mr. Debashish Sen, Principal Secretary S. Kishore, Department of Commerce & Industries, Resident Commissioner Mr. R.D. Meena, and Dr. Krishna Gupta, Managing Director, WBIDC. The program focused on understanding the approach and programs of the West Bengal Government towards developing Smart Cities and related infrastructure projects. Dr. Mitra and his colleagues shared important updates in these areas especially on the State Government's plan for developing six theme-based cities along with the announced four smart cities, as allocated to West Bengal under the centrally announced Smart Cities program. A detailed discussion was held and participating U.S. companies

offering solutions and technologies under the various verticals of Smart Cities, expressed a desire to have a consultative program which focused purely on Smart cities, with the Urban Development Department of West Bengal, under the AmCham platform.

Dr. Mitra also suggested that an IT & ITES focused Investors meet is to be scheduled in Bangalore shortly, where U.S. companies' participation, through AmCham, was welcome. The program details will be worked out in consultation with the West Bengal Government and a program agenda is to be worked out accordingly. Additionally, it was also proposed to have AmCham member companies participate as Summit Partners under a common pavilion, in the upcoming West Bengal Global Business Summit (7-9 January 2016). The discussion outcomes from this meeting will be actioned in the coming weeks and a follow up on the proposed programs is underway.

On 7th September 2015, AmCham and Telangana Government Health Department organized a *Knowledge Workshop on Innovations in Medical Technology* in Hotel Taj Krishna, Hyderabad. The workshop was organized keeping in mind the following objectives:

- Creating awareness about the medical devices industry in India and showcasing the global developments/trends in the Medical Devices Industry
- Providing a platform for interaction amongst various stakeholders i.e. physicians, policy makers, providers and industry to establish the right position for the medical devices industry as the pivot for healthcare industry in the country.
- Deliberating on the possible role that State government and the industry together could play to make Universal Health Coverage (UHC) for the state a reality.

The Workshop was chaired by Shri. Suresh Chanda, Principal Secretary, Department of Health and Family Welfare, Government of Telangana. Mr. Michael Mullins, Consul General, U.S. Embassy, Hyderabad also attended the workshop. Other stakeholders included Dr. Buddha Prakash M. Jyothi, Health Commissioner, Government of Telangana and Medical Superintendents, specialist doctors from government hospitals of various districts and AmCham Medical Devices Committee members.

Welcoming the audience Mr. Prabal Chakraborty, Chairman-AmCham Medical Devices Committee and VP and Managing Director, Boston Scientific India congratulated the Health Secretary and his department for conceptualizing this knowledge workshop and emphasized on the important role of medical devices industry in managing the holistic healthcare for the state

by addressing the disease burden.

Commenting on the occasion, Shri Suresh Chanda, Principal Secretary, Department of Health & Family Welfare, Government of Telangana stressed on the early diagnosis and hence effective treatment of non-communicable disease (NCD) by use of innovative medical technologies. He was also of the opinion that optimal usage of innovative medical technologies has the potential to reduce the overall cost to healthcare in the state and the country.

Mr. Michael Mullins, Consul General of the U.S. Consulate, Hyderabad mentioned that Medical devices play a crucial role in diagnosing and managing diseases by allowing people to live longer, healthier and more productive lives and in health research, the United States and India have established a strong record of cooperation. The U.S. National Institutes of Health (NIH) has developed a robust relationship with India's medical research community in the biomedical and behavioral health sciences. New and ongoing research partnerships focus on diabetes research, low-cost medical devices, and vaccine development.

Dr. Buddha Prakash M. Jyothi, Health Commissioner, Government of Telangana spoke about need for more information sharing programs on new technologies which empowers the government to take informed decisions for the benefit of citizens of Telangana.

The workshop witnessed extensive participation from more than 100 doctors from various district hospitals, HODs, hospital administrators, doctors from Telangana Vaidya Vidhan Parishad (TVVP), Department of Public Health & Family Welfare, National Health Mission and doctors from other districts of Telangana.

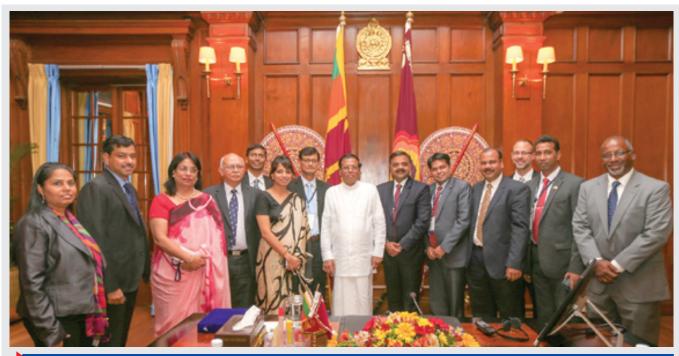
AmCham India Delegation calls on President of Sri Lanka

AmCham-PwC Webcast on Transfer Pricing

On 14th September 2015, AmCham and PwC hosted a webcast on Transfer Pricing. The speakers from PwC were Mr. Sanjay Tolia, Leader, Transfer Pricing; and Mr. Sabine Wahl, Principal and APA Leader. They gave an overview of and insights into recent transfer pricing developments in India to enable the participants to gain a better understanding of the possible impact of the new developments on their business. The focus of the discussion was success of the India APA programme, recent High Court decision on AMP expenses, the recent introduction of the APA rollback rules that could potentially give taxpayers nine years of certainty, amendments to the tax law to address long standing concerns and the resolution of the deadlock between the U.S. and India Competent Authorities on several MAP cases and acceptance of bilateral APAs with India. These important developments would go a long way in addressing the challenging transfer pricing environment in India.

HR Committee's Talent Workshop "Navigating Talent in a VUCA World"

On 30th September 2015, in a first of its kind initiative, HR and Talent Practitioners in Mumbai converged for the Talent Workshop *Navigating Talent in a VUCA World*.

Conceived and led by the Talent Management work stream of the HR Committee, this workshop was facilitated with the objective of bringing together HR and talent thought leadership and co-create a framework for managing talent in our workplaces of the future. The workshop was attended by senior management participants represented a cross section of industry from across BFSI, consulting, retail, technology and information services sectors. The workshop was kicked off with a presentation from the Talent work stream, covering the various macro trends in the environment, their impact on the emerging workplace of the future, the talent challenges faced by organizations, the shifts required to move from the current to the future and the best practices employed by organizations to equip themselves for navigating talent management effectively.

Post this, the participants were introduced to the *Talent Management Framework* that is being developed as a talent management ready-reckoner for organizations, and were segregated into smaller break-out groups to brainstorm on the challenges and come up with their recommendations for managing talent of the future. As the participants, had already been familiarized with the Framework through a pre-work mechanism, they were quick to leverage the opportunity to share, discuss and define strategies for the talent management of tomorrow.

After animated discussions and exchange of best

practices within the break-out subgroups, each of the sub-groups presented their ideals to the larger group facilitating further discussion and augmentation.

The workshop, which ran well over 3 hours achieved two critical outcomes:

- a) Consolidating the Talent Management approach and best practices of a set of companies
- b) Building the blue-print for talent management practices for the future in the form of a Talent Management Framework, through the collective input and experience of over 20 HR and talent practitioners.

The Talent Work stream plans to build further on the Framework by bringing together business leaders and managers of talent in a similar workshop, to test and reaffirm the recommendations of this workshop and is scheduled for November 2015.

On 5th October 2015, an interactive session was held at Bongo Bhavan, New Delhi, on *Theme Based & Smart Cities for West Bengal* for AmCham members to engage with the Urban Development Department of West Bengal Government. The Principle Secretary, Urban Development Department, Mr. Debashis Sen and Resident Commissioner, Mr. R.D Meena along with Mr. Sudip Datta, COO, II & FS, addressed the participants and informed them on a number of Smart City related initiatives that the West Bengal Government had introduced in the state.

Six theme based cities have been identified along with the four Smart cities of New Town, Vidhan Nagar, Haldia and Durgapur that are of immediate interest to the industry and the State Government. Members had an open

interaction on a number of investment related concerns in the areas of Private sector partnerships, procurement, funding and PPP implementation models. It was decided that appropriate engagements will be initiated at the ULB working levels between concerned officials and member companies to work out ways of a deeper level business engagement in the smart city initiatives of West Bengal. Participating AmCham members included companies such as Accenture, AECOM, HP, Dell, UTC, 3M, Pepsi, IBM etc.

AmCham Pharmaceutical Committee Meeting

On 5th October 2015, the first meeting of the AmCham Pharmaceutical Committee for the year 2015-16, was organized in Mumbai. Mr. Sanjiv Navangul, Chairman-AmCham Pharma Committee and MD, Janssen India chaired the meeting. The meeting was also attended by Mr. Nick Mitchell, Co-Chair-AmCham Pharma Committee and MD, Phenomenex India and other members of AmCham Pharma Committee which included representatives from Abbott, Hospira, MSD, KPMG, APCO Worldwide, West Pharmaceuticals, Biogen Idec and Avery Dennison. From AmCham, Mr. Gaurav Mendiratta, Sector Manager-Medical Devices and Ms. Surabhi Wahal, Regional

Director-Western Chapter, AmCham also attended the meeting.

The key objective of the meeting was to brainstorm on the activities to be taken up by the AmCham Pharma Committee in the coming months. A small working group was also formed comprising of representatives from the members present during the meeting. The working group will be working to build a framework for the committee and come out with a roadmap for the committee which will be finalized during the next committee meeting.

AmCham Defense Committee Meeting

On 8th October 2015, AmCham Defense Committee members discussed the letter submitted to Minister Parrikar commending the expert committee recommendations. Based on the earlier AmCham-FICCI Defense Committee collaborations; It was decided that AmCham Defense Committee would hold quarterly meetings with the FICCI Defense Committee. It would help the two

industry associations collaboratively address the potential issues in the sector and jointly make recommendations to the challenges. It was also decided that AmCham and USIBC Defense committees should have interactions on a regular basis. In order to be fact-based and comprehensive, the committee was advised to focus on the specific points outlined by the USDOC, including contract enforcement, insolvency, and transparency, the difficulties and specific suggestions for reform in these areas, things which could be successful, and items that can be accomplished by April 2016.

Mr. Anand Dayal, AmCham Anti-Corruption & FCPA Compliance Committee chairperson along with the cochairperson, Ms. Ritika Rattiare keen to help USDOC for the mentioned document and have already started working on it.

AmCham Defense Committee Meeting

On 30th October 2015, the AmCham defense committee members met to review the offset recommendations submitted to Hon'ble Raksha Mantri and it was decided that a follow on meeting with Hon'ble Raksha Mantri should be requested. The AmCham team also felt that it was imperative to submit key recommendations from the A&D sector to the AmCham Tax Committee for inclusion in their submissions to the Ministry of Finance for the Pre-Budget Memorandum.

An AmCham Exclusive: Interview with Mr. Pratyush Kumar, President, Boeing India

Q 1. We understand that your global Chairman was in India. Can you please share his perspective on "Make in India?"

Soon after India's PM launched the Make-in-India initiative in September 2014, Dynamatic Technologies and Boeing inaugurated a plant in Bengaluru to manufacture critical parts for the Chinook Heavy Lift Helicopters. In a state-of-the-art facility of the Tata company in Nagpur, Boeing manufactures advanced composite floor beams that form the "spine" of the world's most advanced aircraft, Boeing 787-9. In July this year we announced a partnership with Tata to manufacture advanced aero-structures and aerial systems including unmanned. We have significantly upped our manufacturing activities in India, more than doubling our sourcing over the last year. Now, over half a billion dollar in products and services from India gets on our airplanes each year, and we are working to increase that. To further leverage India's deep engineering capabilities Boeing also plans to significantly expand its engineering footprint organically in the near term.

Q 2. What are your comments on the recent defence contract which has been granted to Boeing?

The recent contracts of 22 AH-64E Apache attack helicopters and 15 CH-47F Chinook heavy-lift helicopters further strengthens our position as a long-term strategic partner for India's defense modernization. Boeing is supporting mission-readiness and

modernization of India's defense forces. For example, the C-17s have played a stellar role in numerous relief and rescue missions and P-8Is have enabled the Indian Navy to monitor the vast region of the ocean from the Strait of Hormuz to the Malacca Strait. Apache AH 64E helicopters are the newest members of the combatproven Apache family and one of the most advanced multi-role attack helicopters, combining performance and lethality with more affordable efficient maintenance. The CH-47F Chinook helicopter can carry tons of cargo, including heavy machinery, artillery guns and even light armoured vehicles to high altitudes. This acquisition will not only augment the Air Force's heavy lift capability for military tasks but is a vital addition for the construction of strategic roads and infrastructure projects in difficult terrains. Boeing will also continue to work closely with its defense customers to give superior mission readiness in servicing all our platforms.

Q 3. Is the Indian ecosystem mature enough to absorb the high tech from U.S. especially in the defence sector?

Boeing is working towards preparing the Indian industry for aerospace manufacturing. For example, we have founded the National Center of Aerospace Innovation and Research with IIT Bombay and the government's Department of Science and Technology. We also have existing tie-ups with many Tier-1 engineering firms who manufacture crucial components for some of our most advanced aircraft like the 787-9 Dreamliner. Many of our Suppliers are already at a global standard





of manufacturing. Boeing has been working with India's Tier-1 IT & Engineering Services providers with a significant spread of partner engineers and engineering work statements sourced during the past decade. Boeing subsidiaries like CDG and Jeppesen also have a significant and growing engineering footprint in India. Many other OEM's like us also have tie-ups with Indian partners for the manufacture of components now which is indicative of a growth in the aerospace manufacturing sector.

Q 4. Several member companies are in a 'wait and watch' mode vis-à-vis their expansion plans in India. What advice would you give them?

India is the fastest growing economy in the world and is an extremely important market as well. India is going to remain a big aerospace player in the global market in both commercial and defense, and is poised to play a pivotal role in the evolution of the aerospace &defense industry. India has immense industrial capability, talent and resources that need to be tapped to explore the full potential that is on offer. If factors are favourable and the 'Make in India' initiative continues with the same momentum it has today maybe a shift may take place, moving 25% of the economy towards manufacturing from the existing 14%, to achieve the goal set by the Indian government.

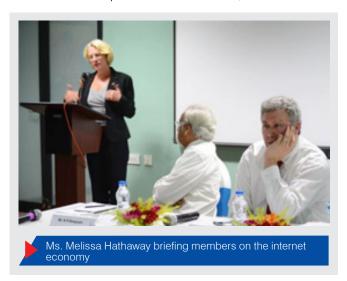

Talk on "Safety and Security: Taking Control of our Cyber Future"

On 23rd September 2015, AmCham in association with the Public Affairs office of the U.S. Consulate Kolkata organized a talk on *Cyber Safety and Security: Taking* control of our cyber future.

Ms. Amada Kidwai, Regional Director AmCham Eastern Region did the introductions, Mr. Dinesh Agarwal, Chairman Amcham Eastern Region in his welcome remarks spoke about the importance of safety and security of cyber space. Mr. Andrew Posner, Director of the American Centre introduced Ms. Melissa Hathaway to members present. Ms. Hathaway, former acting senior director for cyberspace at the National Security Council, has joined Harvard Kennedy School's Belfer Centre for Science and International Affairs as a senior advisor to its cyber security initiative, Project Minerva. It is a joint effort between the Department of Defence, Massachusetts



Institute of Technology, and Harvard University. The project explores a wide range of the issues within cyber security from the contexts of international relations theory and practice.

In her briefing, Ms. Hathaway said that modern societies are in the middle of a strategic, multidimensional competition for money, power, and control over all aspects of the Internet and the Internet economy. She spoke about the increasing pace of discord and the competing interests that are unfolding in the current debate concerning the control and governance of the internet and its infrastructure. Cybersecurity, she said, is a major concern at companies of all sizes and has a measureable impact on many facets of operations, and certainly profitability. Yet the scale of that impact is often obscured or lost in translating the size of the risk and the steps to mitigate it may not be clear. Instead, Hathaway says, the risks need to be translated into a language most directors know well: dollars and cents. She said that in our current state of cybersecurity, breach, crime, disruption and destruction are growing in unacceptable ways. Key indicators suggest that we are not making enough progress and in fact, are possibly going backwards. Hathaway gave an overview of the latest developments in cybersecurity from a U.S. and then global perspective—and discussed what is at stake for companies and nations.

The session was concluded by Mr. K.P. Sengupta who gave the concluding remarks and vote of thanks. The event was hosted by Data Core Systems.

Interactive Breakfast Event with U.S. Consul General, Mr. Craig Hall

On 28th September 2015, AmCham organized a "Welcome to Kolkata" interactive breakfast session for the U.S. Consul General Craig Hall at the Hyatt Regency.

Ms. Amada Kidwai, Regional Director gave the introductions. Mr. Dinesh Agarwal Chairman AmCham Eastern Region in his welcome address briefed the Consul General on the role of AmCham in Eastern India and spoke about the diversity of events held in this region.

Kishore, Department of Commerce & Industries, Resident Commissioner Dr. Krishna Gupta, Managing Director, WBIDC and members of his cabinet. The program focused on understanding the approach and programs of the West Bengal Government towards investment in the State particularly in the areas of Smart Infrastructure, Future of IT and ITeS and Smart Cities and West Bengal Investment Opportunities. Dr. Mitra and his colleagues shared important updates in these areas on Expansion plans of different organizations in the State.

Dr. Mitra also highlighted the following developments: was 10.46%, and that West Bengal was the 5th largest economy in the country.

Dr. Mitra also highlighted the following developments: Maritime Ports & developments of highways being planned with funding from ADB. Mining, tourism, food processing, 8 built up IT parks were also available, optic fiber cable based network project led by Webel, 2 electronic manufacturing cities in Naihati & Palta being developed.

During the Q&A session members asked about the power situation. Dr. Mitra said that West Bengal had surplus power. Questions were asked on the image of WB, the minister responded "perception is worse than reality." Members asked about the labor scene in WB. The Minister said solutions were being derived by working with the Trade Union and that currently there was no labor problems in the state. He said that WB Grew by 10.48% as against India's growth of 7.5%. He said that the GDP

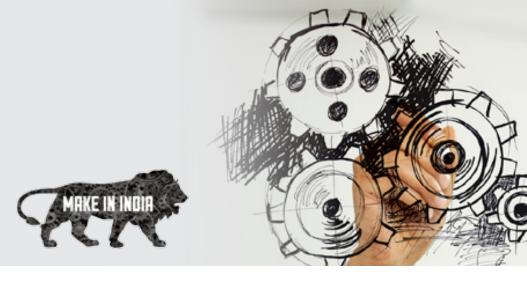
AmCham Eastern Region was represented by Vice Chairperson Britta Leick-Milde and Regional Director Amada Kidwai.

Tamil Nadu's Global Investor Meet 2015

On 8th September 2015, the prelude to the GIM 2015 was a cocktail dinner reception hosted by USIBC, IACC and AmChAM at the Taj Coromandel. This was attended by the USIBC executive delegation led by Ms. Dianne Farrell, Vice President, USIBC, members of AmCham, IACC members, select diplomats from the U.S. Consulate led by Consul General Philip Min and Tamil Nadu government officials. The event was a great networking opportunity. Ms. Dianne Farell welcomed all guests and Consul General Philip Min said that Tamil Nadu has a very favorable investment climate to do business and that it is exciting times for the business community. Several AmCham members participated as well as bureaucrats from the state government, Consulate officers and other prominent city based business leaders.

On 9th September, Chief Minister J. Jayalalithaa inaugurated the Investor Meet at the Chennai Trade Center saying: "Our government is committed to making Tamil Nadu a new growth model among Indian states. I invite you all to be our partners in realizing my vision of making Tamil Nadu the numerouno among Indian states in all spheres of development." This is for the first time that the state hosted a large investor meet. The U.S.-India Business Council (USIBC), an official partner organization, led an executive delegation to the Tamil Nadu Global Investors Meet 2015. The delegation includes senior representatives from member companies including Amway, NCR Corporation, Uber, PayPal, SunEdison, Ford, IBM and General Electric.

Ms. Diane Farrell, Executive Vice President of USIBC

having long supported Tamil Nadu's pro-business environment and this will be the first time Tamil Nadu has held a large-scale conclave to attract global investors as part of the 'competitive federalism' efforts that India is undertaking. The summit aims to help realize the state's vision of inclusive growth through foreign direct investment, job growth, and balanced regional development. The delegates met with key representatives from the Indian industry, Government of Tamil Nadu and the U.S. Consulate in Chennai from 8th – 10th September 2015.

With over 250 U.S. companies across several industry sectors already investing in Tamil Nadu, the Investors Meet was an opportunity to highlight the business-friendly approach undertaken by the state. Farrell added. "This Investors Meet will serve as an excellent opportunity for USIBC member companies interested in a wide range of sectors including aerospace, agriculture, infrastructure, informational technology, and renewable energy."

During the two-day summit, the Tamil Nadu government attracted investments worth Rs.2, 42,160 crores. Around 5,000 delegates from across the world attended with nine partner countries. State government officials said these investments would translate to around 150,000 jobs over the next three years. About 100 MoUs were signed over the two days. Union Minister of State for Commerce and Industry, Ms. Nirmala Sitharaman and Minister of State for Road Transport, Highways and Shipping, Mr. Pon Radhakrishnan presided over the event.

AmCham Breakfast Meeting with Phillip A. Min, U.S. Consul General

Topic: Reflections - One year at the post in Chennai

It is been a year since U.S. Consul General took charge of the U.S. diplomatic mission at Chennai and AmCham members wanted to hear from Consul General Phillip Min, his experiences and thoughts on the past year.

On 29th September 2015, at the beginning of the meeting Consul General Philip Min said he was happy to talk to AmCham members in Chennai, emphasizing that the Consulate will continue to support AmCham in all activities and support American businesses. He further explained his role as the Principal Officer at the American Consulate General and his responsibility for the safety of both American and Indian personnel working at the mission. He added that the smooth working of various departments was part of his responsibilities. The territorial jurisdiction of the mission at Chennai extends to Tamil Nadu, Karnataka, Kerala, Pondicherry and the Andaman & Nicobar Islands besides Lakshadweep.

One of the first things Consul General Phillip Min did soon after arriving in Chennai was to interact with

other diplomats in the city to get a feel of the business environment and life in the state. From these meetings he learnt that the basic requirements were persistence and patience. He said that the Americans are very good at being persistent but they had over time mastered the art of patience.

The CG spoke about the recently concluded Global Investor Meet in Chennai and complimented the manner it was organized. He said that it would be in the states' best interest to follow up on the investment intentions as the state has great potential in terms of talent, infrastructure, ports etc.

Consul General Min also dwelt on how life in the south of India was good with very hospitable people. He added that for him and his wife, living in Chennai meant being at home, since they are quite used to living in the tropics.

He also said that all the officers at the Consulate and him are willing to be available to AmCham members to help American business grow. The meeting ended with a very lively interactive session with members.

On 26th October 2015, the meeting began with opening remarks by Mr. Charles E Luoma - Overstreet, Chief of Consular Services, Consulate General of the United States of America, Chennai who had arrived to his new post in Chennai just under a month ago. He said he was glad to be addressing AmCham members as his first public engagement after assuming responsibility of the post. Mr. Overstreet gave participants a broad overview of the working of the Consular Department and general information on the visa issuances. He highlighted the fact that India is the largest beneficiary of the H 1B visa program and also the L visa program. Mr. Overstreet also spoke of the growing relationship between India and the

USA and the increasing volume of trade. He mentioned that visitors from India to the U.S. have grown by leaps and bounds and this is set to increase in the coming years.

The Guest Speakers Mr. Brock Fox, Mr. Rami Fakhoury, Mr. Matt Morse and Mr. Prakash Khatri made detailed presentations on Immigration aspects and the "Employment Visa" category. The highlights are:

H-1B: Person in Specialty Occupation - To work in a specialty occupation. The job must meet one of the following criteria to qualify as a specialty occupation:

- Bachelor's or higher degree or its equivalent is normally the minimum entry requirement for the position
- The degree requirement for the job is common to the industry or the job is so complex or unique that it can be performed only by an individual with a degree
- The nature of the specific duties is so specialized and complex that the knowledge required to perform the duties is usually associated with the attainment of a bachelor's or higher degree

- Hold a foreign degree that is the equivalent to a U.S. bachelor's or higher degree in the specialty occupation
- Have education, training, or progressively responsible experience in the specialty that is equivalent to the completion of such a degree, and have recognition of expertise in the specialty through progressively responsible positions directly related to the specialty

Application Process

- Employer Submits LCA to DOL for certification.
- The employer must apply for and receive DOL certification of an LCA.





- Employer submits completed form I-129 to USCIS.
- The employer should file form I-129, Petition for a Nonimmigrant Worker, with the correct USCIS Service Center. Prospective Workers Outside the United States Apply for Visa and/or Admission.
- Once the Form I-129 petition has been approved, the prospective H-1B worker who is outside the United States may apply with the U.S. Department of State (DOS) at a U.S. embassy or consulate abroad for an H-1B visa.

Labor Condition Application (LCA)

Prospective specialty occupation employers must obtain a certification of an LCA from the DOL. The application requires the employer to attest that it will comply with the following labor requirements:

- The employer will pay the beneficiary a wage which is no less than the wage paid to similarly qualified workers or, if greater, the prevailing wage for your position in the geographic area in which you will be working.
- The employer will provide working conditions that will not adversely affect other similarly employed workers. At the time of the labor condition application there is no strike or lockout at the employer place of business. Notice of the filing of the labor condition application with the DOL has been given to the union bargaining representative or has been posted at the place of business.

Period of Stay

All H-1B non-immigrants may be admitted for a period of up to three years. This time period may be extended, but generally cannot go beyond a total of six years, though some exceptions do apply under sections 104(c) and 106(a) of the American Competitiveness in the Twenty-First Century Act (AC21).

H-1B Cap

The H-1B visa has an annual numerical limit "cap" of 65,000 visas each fiscal year. The first 20,000 petitions filed on behalf of beneficiaries with a U.S. master's degree or higher are exempt from the cap. Additionally, H-1B workers who are petitioned for or employed at an

institution of higher education or its affiliated or related nonprofit entities or a nonprofit research organization, or a government research organization are not subject to this numerical cap.

Family of H-1B Visa Holders

The spouse and unmarried children under 21 years of age may seek admission in the H-4 nonimmigrant classification. Beginning May 26, 2015, certain H-4 dependent spouses of H-1B non-immigrants can file Form I-765, Application for Employment Authorization, as long as the H-1B nonimmigrant has already started the process of seeking employment-based lawful permanent resident status.

L-1A Intra-company Transferee Executive or Manager

The L-1A nonimmigrant classification enables a U.S. employer to transfer an executive or manager from one of its affiliated foreign offices to one of its offices in the United States. The employer must file a Form I-129, Petition for a Nonimmigrant Worker, with fee, on behalf of the employee.

General Qualifications of the Employer and Employee

To qualify for L-1 classification in this category, the employer must:

- Have a qualifying relationship with a foreign company (parent company, branch, subsidiary, or affiliate, collectively referred to as qualifying organizations); and
- Currently be, or will be, doing business as an employer in the United States and in at least one other country directly or through a qualifying organization for the duration of the beneficiary's stay in the United States as an L-1.

Doing business means the regular, systematic, and continuous provision of goods and/or services by a qualifying organization and does not include the mere presence of an agent or office of the qualifying organization in the United States and abroad.

Executive capacity generally refers to the employee's ability to make decisions of wide latitude without much oversight.



Managerial capacity generally refers to the ability of the employee to supervise and control the work of professional employees and to manage the organization, or a department, subdivision, function, or component of the organization. It may also refer to the employee's ability to manage an essential function of the organization at a high level, without direct supervision of others.

Period of Stay

Qualified employees entering the United States will be allowed a maximum initial stay of three years. For all L-1A employees, requests for extension of stay may be granted in increments of up to an additional two years, until the employee has reached the maximum limit of seven years.

Family of L-1 Workers

The transferring employee may be accompanied or followed by his or her spouse and unmarried children who are under 21 years of age. Such family members may seek admission in L-2 nonimmigrant classification and, if approved, generally will be granted the same period of stay as the employee.

Spouses

Spouses of L-1 workers may apply for work authorization by filing a Form I-765, Application for Employment Authorization with fee. If approved, there is no specific restriction as to where the L-2 spouse may work.

L-1 B Blanket Petitions

Certain organizations may establish the required intra company relationship in advance of filing individual L-1 petitions by filing a blanket petition. Eligibility for blanket L certification may be established if:

- The petitioner and each of the qualifying organizations are engaged in commercial trade or services
- The petitioner has an office in the United States which has been doing business for one year or more
- The petitioner has three or more domestic and foreign branches, subsidiaries, and affiliates
- The petitioner along with the other qualifying organizations meet one of the following criteria:

- Have obtained at least 10 L-1 approvals during the previous 12-month period
- Have a U.S. work force of at least 1,000 employees

The approval of a blanket L petition does not guarantee that an employee will be granted L-1A classification. It does, however, provide the employer with the flexibility to transfer eligible employees to the United States quickly and with short notice without having to file an individual petition with USCIS.

Where an L-1 visa is required

In most cases, once the blanket petition has been approved, the employer need only complete Form, I-129S, Non-immigrant Petition Based on Blanket L Petition and send it to the employee along with a copy of the blanket petition Approval Notice and other required evidence, so that the employee may present it to a consular officer in connection with an application for an L-1 visa.

L-1B Intra company Transferee Specialized Knowledge

The L-1B nonimmigrant classification enables a U.S. employer to transfer a professional employee with specialized knowledge relating to the organization's interests from one of its affiliated foreign offices to one of its offices in the United States. This classification also enables a foreign company which does not yet have an affiliated U.S. office to send a specialized knowledge employee to the United States to help establish one. The employer must file Form I-129, Petition for a Nonimmigrant Worker with fee, on behalf of the employee.

Specialized knowledge means either special knowledge possessed by an individual of the petitioning organization's product, service, research, equipment, techniques, management, or other interests and its application in international markets, or an advanced level of knowledge or expertise in the organization's processes and procedures.

L-1 Visa Reform Act of 2004

The L-1 Visa Reform Act of 2004 applies to all petitions filed on or after June 6, 2005, and is directed particularly to those filed on behalf of L-1B employees who will be stationed primarily at the worksite of an of an employer





other than the petitioning employer or its affiliate, subsidiary, or parent. In order for the employee to qualify for L-1B classification in this situation, the petitioning employer must show that:

- The employee will not be principally controlled or supervised by such an unaffiliated employer
- The work being provided by the employee is not considered to be labor for hire by such an unaffiliated employer

Period of Stay

Qualified employees entering the United States will be allowed a maximum initial stay of three years. For all L-1B employees, requests for extension of stay may be granted in increments of up to an additional two years, until the employee has reached the maximum limit of five years.

Blanket Petitions

Certain organizations may establish the required intra company relationship in advance of filing individual L-1 petitions by filing a blanket petition. Eligibility for blanket L certification may be established if:

- The petitioner and each of the qualifying organizations are engaged in commercial trade or services
- The petitioner has an office in the United States which has been doing business for one year or more
- The petitioner has three or more domestic and foreign branches, subsidiaries, and affiliates; and
- The petitioner along with the other qualifying organizations, collectively, meet one of the following criteria:

- Have obtained at least 10 L-1 approvals during the previous 12 - month period;
- Have U.S. subsidiaries or affiliates with combined annual sales of at least \$25 million or
- Have a U.S. work force of at least 1,000 employees

In order to qualify under the blanket petitioning process, the employee having specialized knowledge must also be a professional.

H-1B Filing Fee- No More Extra \$2000 Filing fee

In August 2010, USCIS has implemented Public Law 111-230 which requires H-1B dependent employers to pay an additional fee of \$2,000. This fee is only applicable to the employers who has 50 or more employees and has more than 50% of h-1b visa employees.

This law has expired on September 30, 2015. So, from October 1st 2015, the H-1B visa dependents will not be paying the additional fee of \$2,000. Removal of this fee will reduce a huge burden on companies that use this visa category.

Interactive sessions
